## Sustainability & Environmental, Social, Governance (ESG) Policy



Abu Dhabi Sustainable Water Solutions Company PJSC (SWS) is a public entity serving customers throughout the Emirate of Abu Dhabi. SWS aims to provide high quality, safe and environmentally friendly wastewater services; SWS's core business being collection, treatment, and disposal of end products.

This policy captures and aligns SWS's management strategic commitments and associated activities to achieve ESG & Sustainability objectives and quantitative targets (SCESTRA-001) across three key sustainability & ESG pillars:

#### **Environment:**

- Ensure an effective Energy Management System to measure and monitor energy consumption, identifying energy savings, energy efficiencies and implementing improvement opportunities (Policy: EnMSP-001)
- Ensure an effective Carbon Management System to measure, monitor & reduce Whole-life Carbon (GHG) emissions across business activities (Policy: CMSP-001)
- Measure & monitor water consumption and waste quantities produced across all business activities, seeking to reduce disposal to landfills by avoiding waste generation, and applying the 3 R's; Reduce, Reuse & Recycle (SOP-2916 Waste Management Standard)
- Continuous improvement of recycled water and biosolids quality to enable sustainable use and circular economy
- Reduce environmental impacts on land, air and water, supporting biodiversity and environmental preservation in areas around pumping stations, treatment works and disposal sites

#### Social & Economic Impacts:

- Ensure Corporate Social Responsibilities (CSR) cover diverse initiatives that leave a lasting positive impact on employees, communities and the environment
- Foster an environment of equal opportunity, access to training & development
- · Create value for SWS, its employees, key stakeholders, the local economy and the community
- Engage with SWS's Supply Chain on ethical sourcing, environmental and social disclosures, promoting ICV and encouraging innovations (Service Provider Ethics and Code of Conduct; www.sws.ae/code-of-conduct/)
